WHO WE ARE



The European Union (EU) established in 2017 at the request of the Iraqi government a civilian advisory mission “EUAM Iraq” to support an **Iraqi-led and Iraqi-owned security sector reform process** towards stability and sustainable peace.

EUAM Iraq’s approach includes **empowerment, strengthening women’s participation and respect for human rights** to promote the development of **effective, inclusive, and accountable security actors** at the service of the population.

EUAM Iraq follows the principle of local ownership and provides strategic advice and assistance in a wide range of security-related areas prioritised by the Iraqi partners:



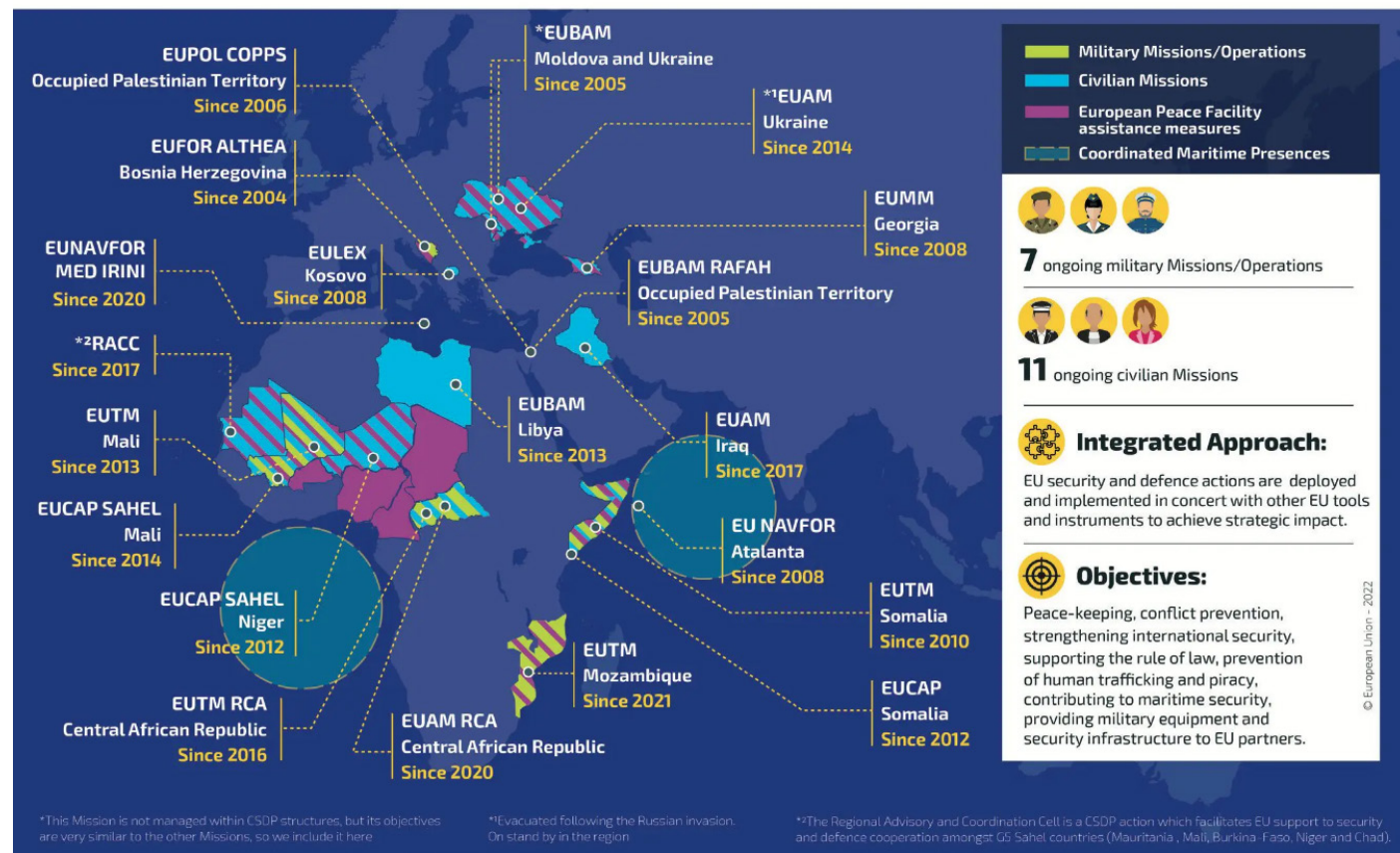

EUAM IRAQ WITHIN THE COMMON SECURITY AND DEFENCE POLICY (CSDP) OF THE EU

EUAM Iraq is one of the civilian CSDP missions of the EU. The CSDP enables the EU to use civilian, police and military instruments to cover the full spectrum of **crisis prevention, crisis management and post-crisis rehabilitation in order to strengthen the international security.** By contributing to local as well as regional stability, CSDP missions, both civilian and military, aim at ultimately contributing to European security as well.

EUAM IRAQ AND THE INTEGRATED APPROACH

The EU's integrated approach to external conflicts and crises aims at **fostering human security by drawing on all relevant EU tools and policy instruments.**



In this way, **EUAM Iraq collaborates closely with the EU Delegation to Iraq, the EU Member States Embassies and other EU actors** to join our forces and tap into synergies for assisting Iraqi institutions and allowing for institutional reform.



An **example of our integrated approach is the CT JUST programme.** A comprehensive training aiming to empower and enhance the capabilities of the Ministry of Interior staff in dealing with counter-terrorism efforts. It is led by the European Commission's Service for Foreign Policy Instruments and organised by EUAM Iraq, and the EU Delegation..
